Subject: **Authority for payment of Enhanced Dearness Allowances @ 36 % w.e.f. 01.09.2023 (enhanced by 4% from the existing rate of 32% to 36%) to regular employees of the Govt. of Mizoram.**

Consequent upon the sanction of Dearness Allowances by the Government of Mizoram vide Finance Department's Office Memorandum No.G.14015/1/2016-FIN(PRU) Dt. 08.09.2023 all Drawing and Disbursing Officers including Self Drawing and Disbursing Officers are hereby authorised to draw the Dearness Allowances at the revised rates from the date as shown below less the amount already drawn.

<u>Period</u>	<u>Revised rate of DA in %</u>	<u>Rate of increase in %</u>
From 01.09.2023	36% of Basic Pay + NPA	4%


Notes :-

1. The enhanced portion of Dearness Allowance shall be impounded into GPF Accounts to all categories of employees under the Government of Mizoram. The amount impounded will not be counted as maximum limit of Rs. 5.00 lakh as can be subscribed in a financial year as prescribed vide Notification No.G.26035/3/2012 dated 20.03.2023.
2. The enhanced portion of Dearness Allowance shall be paid in cash to employees who are due to retire on superannuation within 3(three) months, Income Tax Payers and to employees governed by the New Pension Scheme (NPS) as well as to employees not eligible to subscribe to General Provident Fund with effect from **01.09.2023**.
3. The term "**Basic Pay**" in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix Table but does not include any other type of pay like special pay, etc. However, Non-Practicing Allowance, where admissible, shall be taken into account for calculation of Dearness Allowance.
4. The Dearness Allowances will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9 (21).
5. The Payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and fraction of less than 50 paise may be ignored.
